22.36 **Election of Chairman** for 2022-2023: Cllr Waygood was nominated by Cllr Peace, seconded by Cllr Miller and elected unanimously. Cllr Waygood duly signed the Chairman's Declaration of Acceptance form.

22.37 **Election of Vice Chairman** for 2022-2023: Cllr Norman was nominated by Cllr Waygood, seconded by Cllr Egginton and elected unanimously. Cllr Norman duly signed the Vice Chairman's Declaration of Acceptance form.
